THEIR ASSISTANCE IN DEALING WITH CHALLENGES FROM NATURAL DISASTERS TO EXTENDED DEPLOYMENTS HAS BEEN EXTRAORDINARY.

3. OMBUDSMEN CONNECT OUR COMMANDS WITH NAVY FAMILIES, THEY EASE THE UNAVOIDABLE STRAIN ASSOCIATED WITH LONG DEPLOYMENTS. THEY KEEP THE CHAIN OF COMMAND INFORMED ABOUT CRITICAL ISSUES FACING OUR PEOPLE, FROM HOUSING AND CHILD CARE, TO PAY AND BENEFITS. OUR NAVY IS NOTHING WITHOUT OUR SAILORS. WITHOUT OMBUDSMEN, WE WOULD FIND IT MORE DIFFICULT TO DO OUR JOB. THE PERFORMANCE OF OUR SAILORS IS A TESTAMENT TO THEIR GREAT SUCCESS.
